MOTION 2018 BOT A: It was moved to amend the Bylaws with regard to the terms of office of the trustees as follows:


The initial Trustees of the Corporation shall be those persons specified in the Certificate of Incorporation of the Corporation. All <u>further</u> appointments to the Board shall be for a term of three (3) years <u>with terms staggered such that one third of the board will be elected each</u> <u>year</u>. Each Trustee shall hold office until such Trustee's successor has been elected, or until his or her death, resignation or removal.

NEW BUSINESS

President's Report


- The 2018 conference has 45 registrations including 26 students and 19 non students. There were 3 cancellations and refunds have been sent.
- The general fund contained a balance of \$6571.66 of which \$5000 was used for a deposit at the Minnowbrook. The 2018 conference has taken in \$20,075.00 in registration fees and \$1025.00 in corporate sponsorship for a total revenue of \$21,000.00.
- Total costs for the conference were \$20,850.00 including:

Minnowbrook Conference Center 2015	\$14,850.00
Beverages	200.00
Credit card fee	600.00
Legal fees	25.50
Office supplies	18.12

- After conference expenses, the general fund contained a balance of \$5973.76, leaving sufficient funds to cover the \$5000 Minnowbrook deposit for NEMPET 2019. It was noted that the general fund balance after the 2018 conference will be approximately \$600 less the balance after the 2018 conference. This is likely due to increased credit card costs.
- Craig approached several organizations for corporate sponsorships. Several provided materials for the scholarship raffle.

Scholarship Fund

- The scholarship fund contained \$2889.00 at the conclusion of the 2017 conference and \$1537.50 has since been donated to the fund for a total of \$4426.50.
- Six scholarships were awarded for students to attend the 2018 conference. Four were funded by generous donations from Dartmouth and Rutgers while two were funded by the scholarship fund (\$850).
- The remaining balance in the scholarship fund (\$3576.50) will be supplemented with funds raised in the scholarship raffle (\$176), resulting in post-2018 scholarship fund balance of approximately \$3750. The funds will be sufficient to offer at least 3 scholarship for the 2019 conference.
