

President/Treasurer's Report

- The 2023 NEMPET meeting has 44 attendees (22 students, 19 faculty, 3 guests)
- Regarding finances, the organization's general fund totals \$22,497.26 while the scholarship fund totals \$7984.74.
- Regarding costs of the annual meeting, the Minnowbrook Lodge will cost \$22,878.00. For the last several years, the Minnowbrook has not required a deposit. Seven total scholarships were granted to students for the 2023 meeting (Ed Leadbetter, Bob Mortlock, Doug Eveleigh, Jeanne Poindexter, and three Founders scholarships) for a total of \$4200. This money will be transferred from the scholarship fund to the general fund.
- Incoming raffle money (through Venmo, PayPal, and in cash) should total \$1000 or more. This is approximately twice as much as previous raffles have raised.
- Once all bills are paid, there should be \$3000-4000 left in the general fund. Additional funds and materials were acquired through donations (McGraw Hill gave \$1000, M2P2 paid for 1 scholarship, other monetary donations were made of approximately \$1000; raffle donations are noted in the program)
- Given the balance between revenues and costs, NEMPET remains financially sound.
